The law of Fast means that only one main meal is taken, with two smaller meals allowed. Nothing is to be eaten outside these meals.

It is also a **DAY OF ABSTINENCE** for those who have reached their 14th birthday. The law of abstinence means that no flesh meat is to be eaten on the day of abstinence.

*These are the current regulations for Lent officially established by the Church. They are ridiculously minimal, and represent a radical surrender of the Church to the spirit of the world. Serious Catholics who want to make a more penitential Lent are encouraged to follow the traditional Lenten fast: That is, every weekday of Lent is a day of fast, and partial abstinence. Partial abstinence means that meat may be eaten only at one meal each day. Remember, Our Lord said, "Unless you do penance, you shall all likewise perish."

Bishop Strickland's Open Letter to the Cardinal Electors

Your Eminences,

Very soon, you will travel to Rome with the intention of electing a Successor to St. Peter. I know that you take your responsibility to elect a true and holy pastor seriously. Yet, as the conclave approaches, I feel bound in conscience to share my deep concern-which I know is shared by many bishops, clergy and members of the lay faithful-that this conclave will attempt the election of a man ineligible to hold the office of pope.

Therefore, with the greatest humility, I ask you to keep in mind that the papacy is not a human political institution to be passed between factions but rather a divine institution established by Our Lord Jesus Christ for the salvation of souls. This is also why I take this opportunity of recalling to your mind that there are conditions established by divine law that govern papal elections. Only an individual of the male sex who possesses the use of reason and is a member of the Catholic Church can be elected to the Roman Pontificate. And, as Pope Pius XII and the whole tradition of the Church teaches us, there are three conditions for membership in the Church: (1) valid baptism, (2) public profession of the Catholic Faith, and (3) obedience to the legitimate authorities of the Church, (Pius XII, Mystici Corporis, #22). A man who does not fulfill these conditions is not a member of the Catholic Church and cannot be elected her visible head. Any attempt to elect him as pope would be null and void. Your Eminences, I would also recall to your mind that you have a grave obligation before God to refuse to give assent to the election of any candidate who does not fulfill the conditions established by divine law. If a public heretic, or a man who is reasonably suspected of being a public heretic, receives sufficient votes, faithful cardinals have an obligation to refuse to accept the validity of his election. The suffering and confusion of the faithful have now reached a level unparalleled in the history of the Church. As you and I both know, this crisis is causing many men, women and children to lose their faith, and many more are falling into mortal sin. These are the souls for whom Our Lord died and with whom he wishes to spend eternity in eternal bliss.

Your Eminences, if a false pontiff is presented to the world as the pope, I fear many more souls will be lost. All those cardinals who consent to this invalid election will share that responsibility with him...

I beg you, on behalf of the suffering faithful, not to place your trust in political strategies or human prudence, but only in the Divine Wisdom of Our Lord Jesus Christ. He is God; he can do all things. Our part is simply to follow His commandments and leave the rest to Him. May God bless you at this moment in the Church's history, and may He give faith and peace in the midst of trial.
