## Our Parish's Liability for the Sexual Abuse Scandal

This past Wednesday, the Pastors of the Diocese were informed of their parish's share in the overall \$100 million payment to the Victims of the sexual abuse committed by priests, religious and lay members of the Diocese of Syracuse. We had been apprised in an earlier meeting that the parishes would be charged with "substantial amounts" of payment to meet this court-approved settlement. At that time, a figure was given us based on the 2022 financial report of our parishes, but the actual, final amount owed would be based on the 2023 financial report.

So, this past Wednesday we learned that the indebtedness of the parish of Our Lady of Good Counsel would be \$344,016.00. Now, take a few very deep breaths and revive yourself. That is what I had to do when presented with this figure.

How did the Diocese arrive at the amount to be levied against each parish? Well, basically, they divided the parishes into categories, based on the amount of savings or assets that the parish reported. They then figured out what percentage of that amount would be exacted from each of the categories. The higher your savings, the larger the percentage of your savings would be taken. The highest category, for parishes with over a million dollars, was 55%. Our parish has savings in the amount of \$706,072. We fell into the category from which 47% of the amount of the savings would be exacted. Thus the \$344,016.

As devastating as this news is for us, we can thank God, that we will still have a "cushion" in savings to fall back on should the economy change or some catastrophe strike, God forbid.

In figuring out these percentages, the officials of the Diocese told us that there were 50 parishes of the Diocese who would find continued operation very difficult with this levy. They tried to tilt the percentages to the advantage of these parishes. (But all parishes are being charged with payments into the fund, at very considerable sacrifice).

Bishop Lucia expressed once again, his relief that the Bankruptcy filing was now completed, and that hopefully we can "move on" in doing the mission that is entrusted to us of bringing the Gospel of Jesus Christ to our portion of the vineyard of the Lord. He also told us that in order to settle with the Victims' committee for this amount, he needed the permission of the Holy See. He asked for and received the permission, with the stipulation that no churches or properties were to be sold in order to raise these funds.

As of now, the Insurance Companies have not yet committed themselves as to what amount they will contribute to the fund. I have asked our Chancellor for the following information, which I have not received as of bulletin publishing time: how many victims were there in total to be paid by this settlement?; how much was paid out by the Diocese to victims prior to the bankruptcy settlement?; how much has the Diocese had to pay in legal fees thus far. In October, we were informed that the Diocese had, up till then, paid about \$10 million in lawyers' fees.
