THE VACCINATION ISSUE

As we are now in the throes of a new surge of Chinese virus (Covid-19) infections, there has been tremendous pressure to approve a vaccine that would protect the population from the disease. A little over a week ago, the FDA approved a vaccine manufactured by the Pfiizer pharmaceutical company. It is already being distributed to first responders, health-care workers, and nursing home residents in NYS.

Last Monday, the United States Conference of Catholic Bishops issued a statement which condoned the use of the Pfizer vaccine and one produced by the Moderna company. This statement was issued having relied on the medical-moral experts who advise the Bishops on these matters. One such expert is the well-known Fr. Tadeusz Pacholcayk of the National Catholic Biomedical Center. It was from an article of his that your Pastor based his sermon last weekend on the admissibility of these two vaccines for use by Catholics.

The Bishops and their moral theologians cite this statement from the Congregation of the Doctrine of the Faith, *Dignitas Personae*, issued in 2008: "Grave reasons may be morally proportionate to justify the use of such 'biological material' (i.e. cells from aborted infants). Thus, for example, danger to the health of children could permit parents to use a vaccine which was developed using cell-lines of illicit origin, while keeping in mind that everyone has the duty to make known their disagreement and to ask that their health-care system make other types of vaccines available."

And yet, many faithful Catholics are uncomfortable with using a vaccine that is derived from the cells of aborted children, regardless of how long ago, or how far-removed in cooperation with that abortion the vaccination is. Bishop Strickland of Tyler, TX has stated that he would not use a vaccination that is derived from an aborted infant. There are vaccines being prepared that are not derived from aborted babies.
