SHOULD THE SUPREME COURT RETURN ABORTION TO THE STATES TO DECIDE?

No, it is not. The Supreme Court justices have the ability, if not the obligation to revisit the Roe v. Wade and Doe v. Bolton decisions of January 22, 1973, and to undo the deadly harm that was done that day.

We know that, during the hearings on Roe and Doe decisions, the justices refused to hear scientific evidence regarding the fact that a human being exists from the moment the sperm and the egg meet.

Human embryologist C. Ward Kischer wrote about this error, explaining: "In the early 1950's a coordinated attack on the principles supporting the prohibition on abortion began to enter the public discourse. Eventually, this all culminated in the 1973 Supreme Court decision, Roe v. Wade, which brought forth a plethora of comments on human embryology, many of which proved not to be true." And it is those falsehoods that laid the foundation for the erroneous Roe and Doe decisions.

Therefore, because of the abortion cases before it, today's Supreme Court has a golden opportunity to undo the tragic scientific errors of 1973, recognize that the preborn child is in fact an individual human being from his beginning, and rule that the act of abortion is an act of killing, which is already against the law.

The question is, does the current Supreme Court have the will to do what is right and just?

As pro-life Americans, our goal is to ensure protection for every one of our fellow human beings from his biological beginning onward. And our hope is that the Supreme Court justices see the truth and see and understand their obligation to apply equal justice for all-born and preborn-under the law.
