UPDATED REGULATIONS FOR CONTROLLING THE MASSES

This week we received the latest revisions to the regulations in force regarding the "pandemic". Among the most significant are:

We are now allowed 50% capacity of the church for Mass. Outside of Mass, only 100 people are to be allowed. Outdoors, no more than 200. Masks must continue to be worn by children 2 and up!

Choirs may return (!!!), as long as they are 12 ft. away from the congregation.

The dispensation from the Sunday Mass obligation is in effect ONLY for those who need it because of health or age.

SOME INTERESTING FACTS ABOUT THE "PANDEMIC"

With a constant stream of information and nauséam about the "pandemic", it might be interesting to know these facts:

-The infection fatality rate is so low that 99.9% of young people to 99.5% of older adults, to 94.6% of elderly (over 70 years)

DO NOT DIE of the virus. The renowned Stamford epidemiologist, John Ioannidis MD, reports that only 0.15-0.20% across all ages, and only 0.03-0.04% among people under 70 who get the Wuhan virus die.

-The overall mortality rate in the U.S. From 1997-2007 from *seasonal influenza*, based on CDC data has been a comparable 0.12% with risks of dying from influenza among the elderly 75 and older, 141 times higher than those under 49.

-Government and legislative actions using the Covid-19 "pandemic" have enabled large health care industry hospitals to gain enormous profits. The *Cares Act* awarded a \$175 billion dollar Relief Fund, which equated to a payment of \$108,000 per hospital bed, along with \$100 billion dollars to give hospitals 20% increased reimbursement for Covid-19 patients. Hence, the pressure on doctors to list Covid as the cause of death on so many cases where, in fact, death was due rather to other causes.

-Covid-19 tests themselves mean big money. Medicare reimburses hospitals and healthcare providers \$51.31 for each PCR test (CPT code 87635) and \$42.13 for every antibody test (CPT code 86769 and 86328), and \$45.23 for antigen tests (CPT 87426).

-The U. S. Department of Health and Human Services awarded nearly \$583 million in May 2020 for HRSA health centers to enable expanded Covid-19 testing. According to the Covid Tracking Project, as of March 2, a total of 357,068,278 PCR tests have been done in the U.S. So, just at Medicare reimbursement rates, health care providers in the U.S. Have made \$18.2 billion performing Covid-19 PCR screening tests.

-In actuality, hospitals are charging much more for each test, billed to patient's insurance companies with the balance paid out-of-pocket by the patient. Hospital Pricing Specialists, LLC, surveyed EZCOST data (billed charges) charged by 2,862 hospitals across the country and reported that most were charging many times the CMS rates.

Likewise, hospitals have an interest in hyping the vaccine, because they get reimbursed for administering the vaccine: \$28.39 for the single dose vaccine and \$45.33 for the two-dose vaccine.
