FL SURGEON GENERAL WANTS ANSWERS TO QUESTIONS ABOUT COVID-19 VACCINES

Dr. Joseph Ladapo, Surgeon General of Florida, this past Wednesday put out questions for the head of the FDA regarding a study that alleged the contamination of mRNA COVID-19 shots with plasmid DNA.

He asked Dr. Robert M. Califf MD, MACC, the head of the FDA to address the DNA fragments detected in the mRNA COVID shots and how they are hitchhiking into human cells, acknowledged by @US FDA in '07. [pic.twitter. Com/V7/BaeM1WN](https://pic.twitter.com/V7/BaeM1WN).

In his 6 December letter to the FDA, Ladapo wrote to share his concern about the “recent discovery of host cell DNA fragments within the Pfizer and Moderna COVID-19 mRNA vaccines. This raises concerns regarding the presence of nucleic acid contaminants in the approved Pfizer and Moderna....vaccines.”

LifeSiteNews reported in October, that a study undertaken by researchers David J. Speicher, Jessica Rose, L. Maria Gutsch, David M. Wiseman Ph.D, and Kevin McKernan had “found billions to hundreds of billions of DNA molecules per dose” that they gathered from “expired unopened vials of Pfizer-BioNTech [shots]...and Moderna Spikevax mRNA jabs “obtained from various pharmacies in Ontario, Canada.

According to them, the “preliminary evidence...warrants confirmation and further investigation.”

An earlier preprint in June published by McKernan and his fellow researchers alleged that a fragment of “monkey virus” genome, SV40, had been discovered in the COVID-19 jabs. The study noted that SV40 had previously been discovered in polio vaccines in the 1950's and 60's and was linked to cancer. However, Health Feedback has noted that the DNA found in the COVID-19 jabs was only a “fragment” of that genome, and it is unclear whether SV40 causes cancer in humans (current research only supports risk of cancer in certain animals).

Moreover, the polio jabs became contaminated due to the use of monkey kidney cells to grow the virus, per Health Feedback. Those cell cultures were not used in the making of the COVID shots, making it unclear how the SV40 contaminants got into the injections to begin with.

In his letter to the FDA, Dr. Lapado cited 2007 guidance from the FDA itself, that raised the possibility that the “DNA integration could theoretically impact a human's oncogenes...the genes which can transform a healthy cell into a cancerous cell,and could therefore, result in chromosomal instability.”
