### The United Nations and Sex with Minors

The issue of the sexploitation of minors is about to explode on the public conscience with Jim Caviezel's new film, due out next month, *The Sound of Freedom.* The widespread trafficking in minors to sex abuse is a horrific practice of enormous proportions. The names of those who are involved will shock the public, or perhaps, will come as no surprize. Because so many of the rich and famous are so intricately involved, it is no wonder that the United Nations is currently seeking to legitimatize consensual sexual relations between adults and minors.

Back in 2018, leading world news outlets called our attention to the shocking story that UN staff were responsible for over 60,000 cases of sexual exploitation, including rape and sex with underage persons. "There are tens of thousands of aid workers around the world with pedophile tendencies, but if you wear a UNICEF T-shirt, nobody will ask what you're up to," said Dr. Andrew McCleod, former chief of operations at the UN's Emergency Coordination Center in an interview. What's more, these 60,000 cases were perpetrated by 3,300 known pedophiles working within the organization. In the wake of these offences, a team of jurists commissioned by the UN now appears to be promoting the idea of sex with minors. A March 2023 publication of the International Commission of Jurists claims that *children have the legal right to have sex with adults.* Here is a direct quote from that document: "Sexual contact involving persons below the domestically prescribed minimum age of consent to sex may be consensual in fact, if not in law."

Furthermore, the report states "The enforcement of criminal law should reflect the rights and capacity of persons under 18 years of age to make decisions about engaging in consensual sexual conduct and their right to be heard in matters concerning them...Pursuant to their evolving capacities and progressive autonomy, persons under 18 years of age should participate in the decisions affecting them, with due regard to their age, maturity and best interests, and with specific attention to non-discrimination guarantees."

According to Grace Melton, a Trump Administration appointee to the UN and analyst at the Heritage Foundation, "Not only does (the report) suggest that minors may be mature enough to consent to sexual activity, but it also asserts that "criminal law may not in any way impair the so-called right to an abortion or to "gender affirming care'. Furthermore, the report states "Consensual same-sex, as well as consensual different-sex relations, or consensual sexual relations with or between trans, nonbinary, and other gender-diverse people, or outside marriage, whether pre-marital or extra-marital-may never therefore, be criminalized.
