AT IT AGAIN!

How well we should know that the devil never sleeps! Legislation that would allow assisted suicide in the state of New York has been re-introduced in 2023, and supporters of that legislation held a rally in Albany on 17 January 2023!

The assisted suicide bill, S.2445-Hoylman-Sigal/A.995-Paulin, would let physicians prescribe lethal drugs to terminally ill patients who are expected to die within six months. It is illegal in New York to assist another person in attempting suicide, currently. The proposed Legislation would create an exception to that ban in situations where terminally ill patients request lethal drugs.

New York's ban on assisted suicide has been upheld as constitutional both in the Supreme Court of the United States and by the New York State Court of Appeals.

The Catechism of the Catholic Church states: ``Everyone is responsible for his life before God who has given it to him. It is God who remains the Sovereign Master of life. We are obliged to accept life gratefully and preserve it for his honor and the salvation of our souls. We are stewards, not owners, of the life God has entrusted to us. It is not ours to dispose of." (#2280).

"Suicide contradicts the natural inclination of the human being to preserve and perpetuate his life. It is gravely contrary to the just love of self. It likewise offends the love of neighbor because it unjustly breaks the ties of solidarity with family, nation, and other human societies to which we continue to have obligations. Suicide is contrary to love for the living God." (#2281).

The good news is that, to date, the bill has been sponsored by 52 members of the Assembly, whereas in 2021-22, 56 members of the Assembly sponsored it.

Sen. Brad Hoylman-Sigal (D-Manhattan) is the new sponsor of the bill in the state Senate.
