Nonetheless, the Diocese will still be asking us for the \$20,545 we have been assessed for this year's Appeal. If we don"t "make our goal", as they love to say, the balance has to be made up out of our savings, and they will be very much reduced once we have to pay the levy for the sex abuse scandals. So, I ask you to find it in your heart to do something for this year's HOPE Appeal. As of 1 October only 19 households had responded to this year's Appeal, donating \$2245.00.
